We reserve the 5.3 right to change these terms and conditions without prior notice. With this agreement, you are 5.4 agreed to accept and be bounded by those terms and conditions that are in effect at the time of your occupancy.

1. Room Occupancy

- 1.1 We only allow the residence whose name is in the list to use the room for housing purposes only. You are not allowed to transfer the right of your reside to others.
- 1.2 You have the duty and responsibility to maintain the condition of the room and assets inside the room. You are liable for any damage that occurs during the period of the contract

2. Assignment of the Room

- 2.1 We reserve the right to assign the room (according to the room type you requested) where it seems appropriate.
- 2.2 We reserve the right to impose room changes for the reasons of management, repairs, security, etc.

3. Rate of Rental Fees and Utilities Expenses

- 3.1 We reserve the right in determining the rate of rental fees and Utilities expenses.
- 3.2 We reserve the right to correct any typographical and/or computational errors in the preparation of contracts and on the notice board. It is your duty to check the notice board 6.5 regularly.

4. Payment.

4.1 The rental fees and utility expenses shall be settled through payment at Krung Thai Bank or International Office. It is your responsibility to make sure that you will deposit / transfer the required amount of total housing costs within the given period of due payment before you moving in.

4.2 Following items classified as "debt":

- 4.2.1 Overdue utilities fees such as electricity expense (we will charge at a rate of 6 Baht per unit of electricity usage).
- 4.2.2 Repair expenses from any damage to the equipment and/or assets inside the room and building.
- 4.2.3 Lost of room key will be charged 100 Baht. Room key will need to be returned when student have checked out. If room key is not return at the end of contact, student will be charged 100 Baht.

- 5.7 Usage of fireworks and other items deemed dangerous to others.
- 5.8 Anything illegal by law.

6. Damages and Responsibilities

- 6.1 You shall agree to use the room for your occupancy purpose only. You shall not use the room to find other benefits and/or let other people stay in your room. No sublet is allowed.
- 6.2 You are prohibited to add, adapt and/or change the room or any part of the building from the original setting including installation of any equipment or materials.
